#### Financial Performance for the Half Year ended on 30th June 2021

- The total revenue for the 1<sup>st</sup> half of 2021 is QAR 551.31 million in comparison to QAR 662.06 million for the same period last year.
- ➤The Gross Profit for the 1<sup>st</sup> half of 2021 is QAR 135.56 million in comparison to QAR 155.40 million for the same period last year.
- ➤The Net Profit for the 1<sup>st</sup> half of 2021 is QAR 104.31 million in comparison to QAR 107.02 million for the same period last year.
- ➤The EBITDA for the 1<sup>st</sup> half of 2021 is QAR 141.58 million in comparison to QAR 152.92 million for the sane period last year.


