### Financial Performance for the 2<sup>nd</sup> Quarter ended on 30<sup>th</sup> June

- ➤The total revenue for the 2<sup>nd</sup> Quarter of 2024 is QAR 733.23 million in comparison to QAR 738.07 million for the same period last year.
- ➤The Gross Profit for the 2<sup>nd</sup> Quarter of 2024 is QAR 184.61 million in comparison to QAR 156.63 million for the same period last year.
- ➤ The Net Profit for the 2<sup>nd</sup> Quarter of 2024 is QAR 93.13 million in comparison to QAR 90.02 million for the same period last year.
- ➤The EBITDA for the 2<sup>nd</sup> Quarter of 2024 is QAR 137.90 million in comparison to QAR 138.98 million for the same period last year.


