- The Net Profit for 3rd quarter of 2021 is QAR 134.84 million in comparison to QAR 138.03 million for the same period last year.
- The EBITDA for 3rd quarter of 2021 is QAR 175.26 million in comparison to QAR 186.63 million for the same period last year.

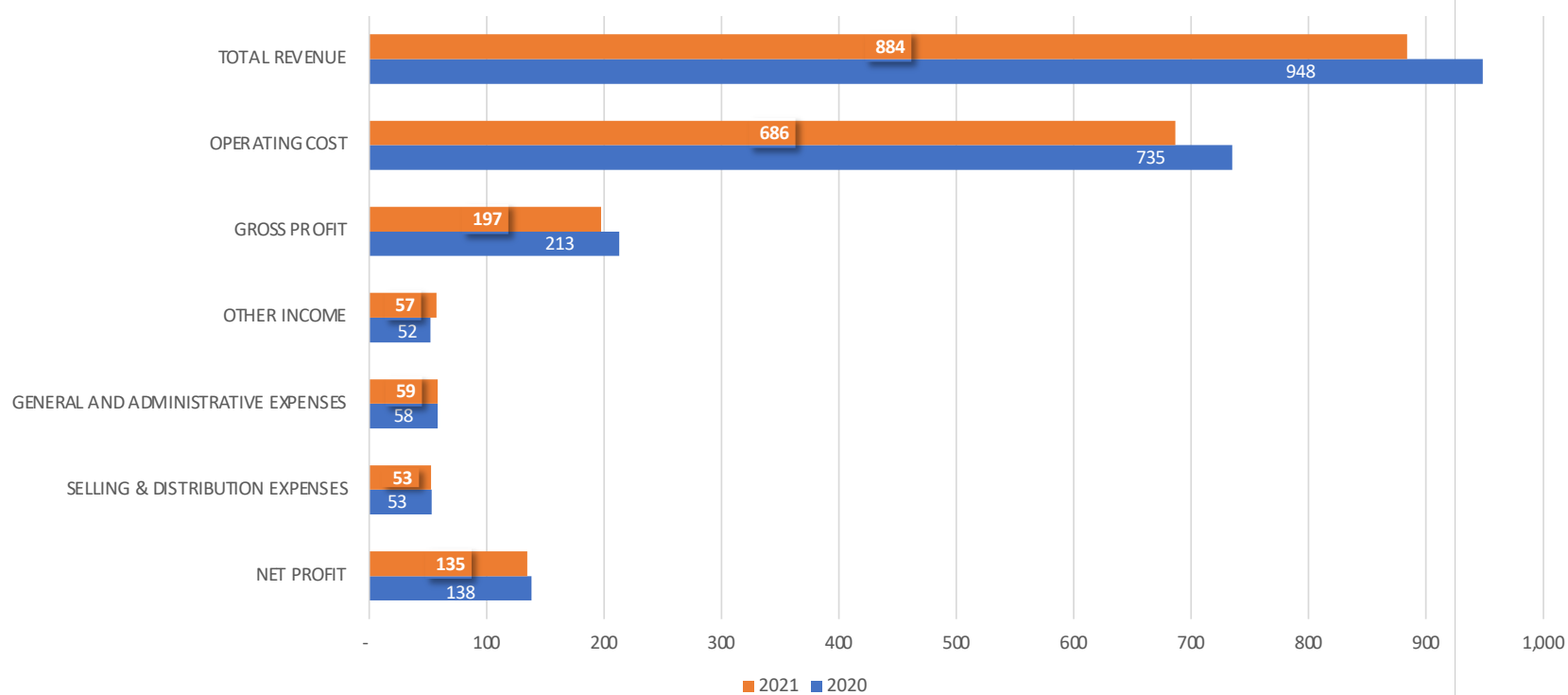
